Upcoming Start of Full Bridge Closure with Detour


Rehabilitation of Baldwin Corners Road Bridge over the Champlain Canal

Dear Supervisors Haff and Hogan:

We are writing to advise you that the next phase of this project, requiring a full closure of the Baldwin Corners Road bridge, is scheduled to begin on Monday, June 26. As shown on the detour map below, during the closure period all traffic will be directed to a detour route using Route 4, Route 149, County Route 17 and Hall Road. We currently expect this closure to be in force until Monday, September 4. The Contractor will be assessed a monetary penalty for failure to have the bridge open for traffic prior to the start of the fall 2017 school year.
